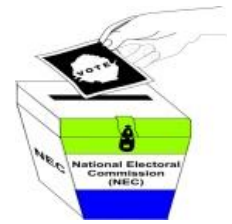

PUBLIC ELECTIONS ACT 2012 (SECTIONS 67 AND 70)
