**NOMINATION OF MAYORAL, DISTRICT CHAIRPERSON AND COUNCILLOR CANDIDATES FOR THE CONDUCT OF LOCAL COUNCIL ELECTIONS ON MARCH 7<sup>TH</sup>, 2018.**

1. In exercise of the powers conferred on it by Section 33 of the Constitution of Sierra Leone, 1991( Act No. 6 of 1991); and pursuant to provisions of Sections 103, 104, 105, 69 and 70 of the Public Elections Act, 2012 (Act No. 4 of 2012) and Section 10 of the Local Government Act 2004 (Act No. 1 of 2004 ), the National Electoral Commission (NEC) makes the following proclamation:
2. **Wednesday, 3<sup>rd</sup> to Sunday, 14<sup>th</sup> January, 2018** is hereby declared as the period for nominations of Candidates for the conduct of Local Council Elections.
3. The deadline for Political Parties to submit the List of Endorsed Candidates for the said Nominations to the National Electoral Commission (NEC), in accordance with **Sections 61 and 62 of the Public Elections Act, 2012**, (Act No. 4 of 2012) is **Thursday 28<sup>th</sup> December, 2017**.
4. Eligible Sierra Leoneans may also contest as Independent candidates for the Local Council Elections.

In accordance with Statutory Instrument No. 13 of 2012, the candidates's nomination fees for the said Local Council Elections is **FIVE MILLION LEONES (Le.5,000,000.00)** for Mayor and District Chairperson; and **ONE MILLION LEONES ONLY ( Le. 1,000,000.00)** for Councillor, payable to the District Returning Officers in the respective districts.
7. Qualifications and disqualifications of Members of Local Councils are found in Section 6 of the aforementioned Local Government Act, 2004 (Act No. 1 of 2004).
8. Other details for the nomination and conduct of the said elections shall be published by the National Electoral Commission in due course.
